Note:- (5) Candidates included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal for state employment purpose along with other documents at the time of OTR verification of original documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
