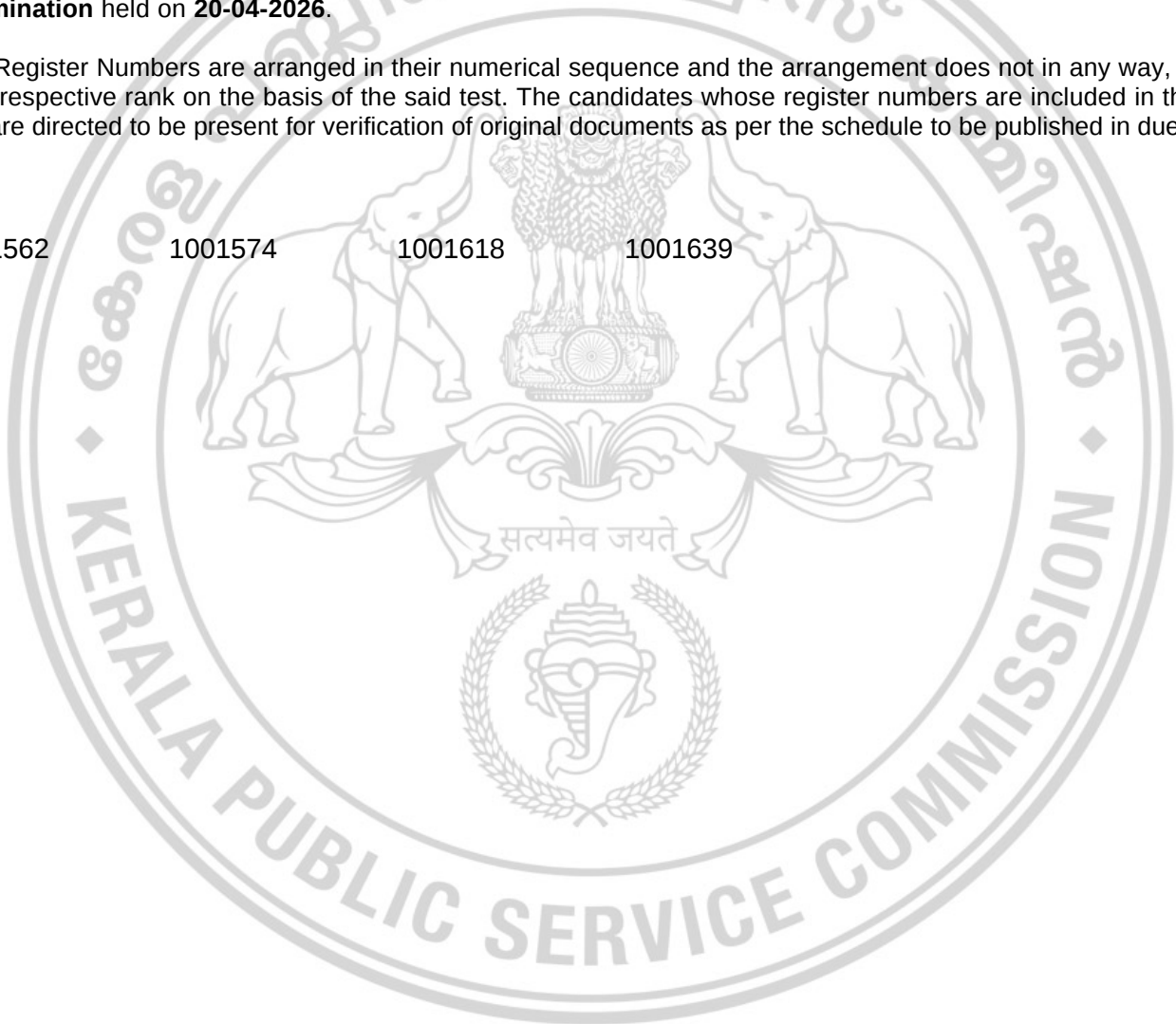

Note:- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/STDD dated. 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 along with other documents at the time of One Time Verification of original documents.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked list. Detailed instructions will be published in the Ranked list to be published for the post.

Note:- (8) Copy of answer scripts of the OMR Test held on 20-04-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
