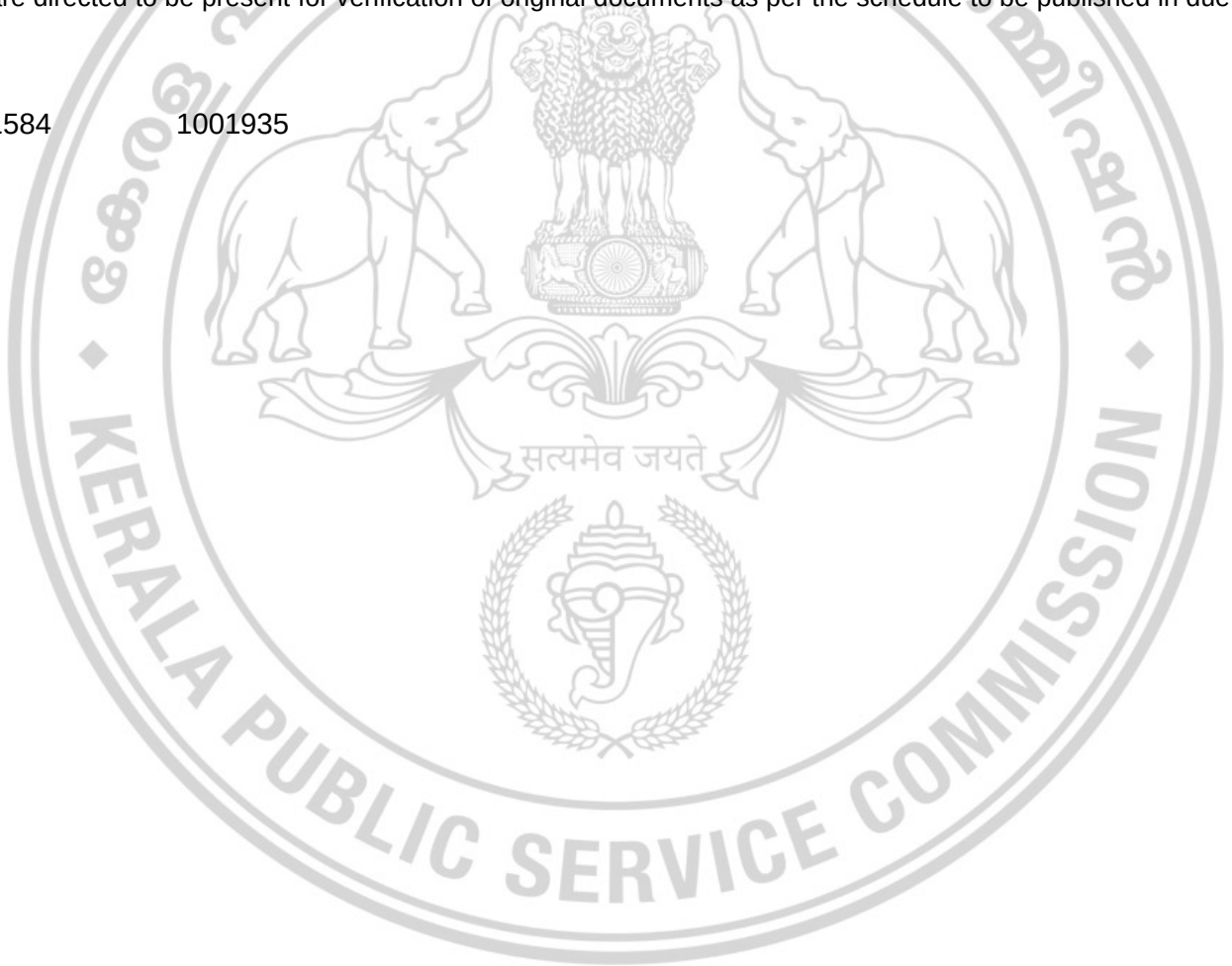

Note:- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date,Time and Venue of One Time Verification and Interview will be intimated to the candidates through profile message and SMS in due course.**

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note:- (6) Candidates included in the Short List are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents.

Note:- (7) According to the existing procedure revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of the Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (8) Copy of answer scripts of the Common OMR Test held on 20.04.2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER7-3/5/2026-KPSC Dated 08.06.2026.
