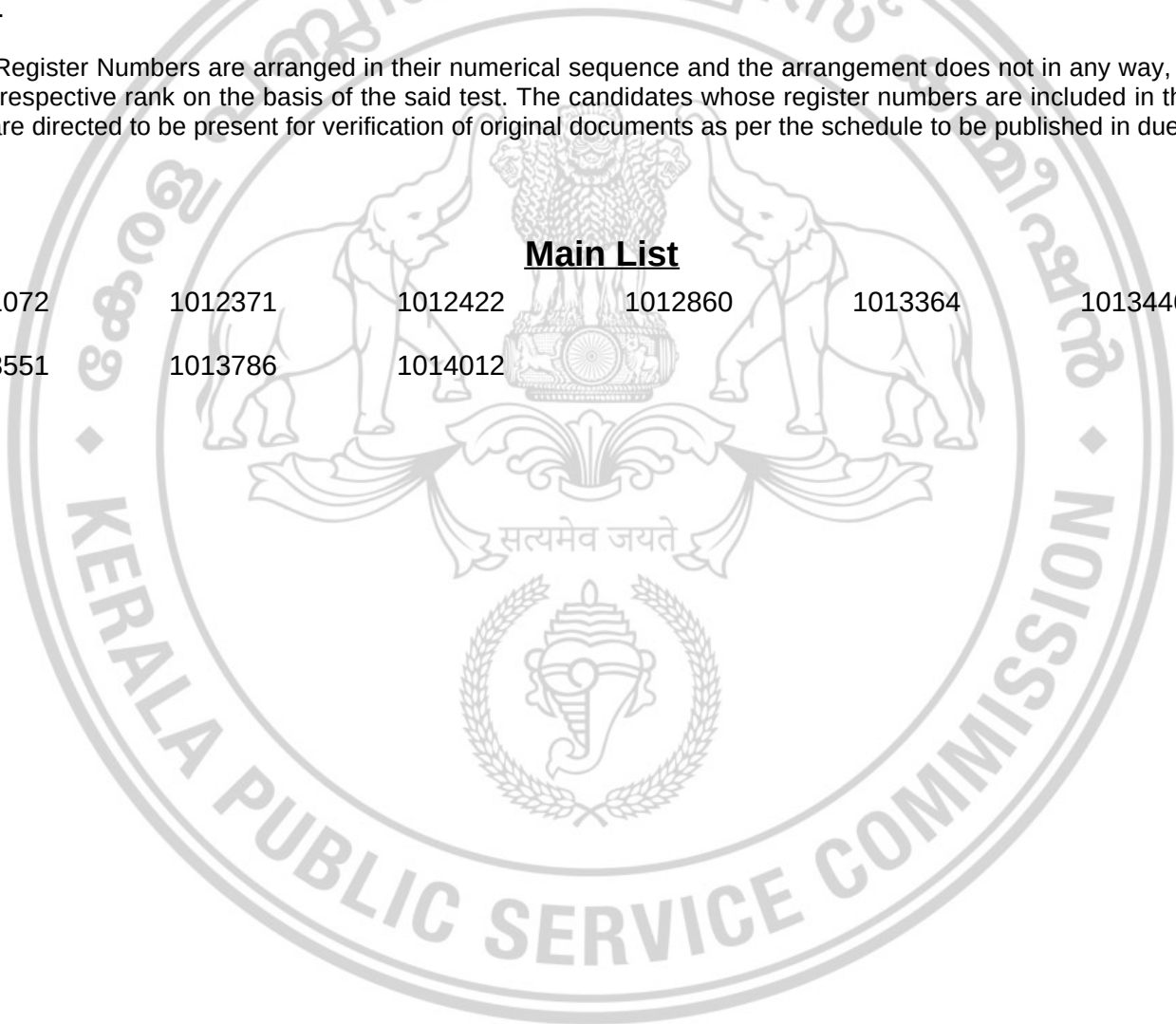

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (7) Candidates included in the Short List are required to produce Non-Creamy Layer certificate issued by the Revenue authority at the time of OTR Verification.

Note:- (8) Copy of answer scripts of the OMR Test held on 17-04-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER2-1/3/2026-KPSC Dated. 06.07.2026.
