The following is the list of candidates for selection to the post of **Civil Excise Officer (Trainee) FIRST NCA DHEEVARA** on Rs.27,900 – 63,700/- in Kerala Excise and Prohibition Department in Kozhikode District, based on the OMR test held on 17/05/2025,Endurance Test held on 16.09.2025,17/09/2025,18.09.2025 and Physical Efficiency Test held in November 2025 for the recruitment against NCA vacancy for Dheevera Community found suitable by the Commission and arranged in the order of merit. This Ranked List is brought into force with effect from **29.01.2026** and will be valid until the candidates are advised and appointed against the vacancies earmarked for Dheevera Community but remain unfilled due to the paucity of candidates during the currency of the Mother Ranked List published on 30.06.2023 (Cat No.538/2019) for the post.

NOTE (1) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's Official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Application submitted in any other manner (ie., via Email/Tappal/Direct) will not be considered. A period of 15(Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the Website of the Commission .

NOTE (2) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit Online Application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees Three Hundred and Thirty Five Only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission . Application submitted in any other manner(ie., via Email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Please note that in case of Ranked Lists of those posts for which common examinations were conducted, the copy of OMR Answer sheets will be provided only after the publication of all the Ranked Lists of those posts for which the candidate has participated.

NOTE (3):-The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents.

NOTE (4) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an Application in the format prescribed by the Commission addressed to District Officer ,Kerala Public Service Commission, District Office Kozhikode either directly or by post. The format is available in the Official website of the Commission. The request for relinquishment in respect of those who do not submit the Relinquishment Application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment should be attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested Copy of an ID Proof bearing Photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of uploading of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (5) :- Since a common OMR test with common candidates was conducted for this post, the mark awarded to the candidates included in the Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked List (including NCA Notification) which will be finalized on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course.

NOTE (6):-The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked list finalised on the basis of the Common Test held on 17/05/2025 .
