Note:- (5) Candidates included in the Short List are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009 as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (7) Copy of answer scripts of the OMR Test held on 23-05-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts of the candidates were invalidated as per Notification No : ER 7-1/5/2026-KPSC dated 06.08.2026 of the secretary, KPSC.
