**Note:- (5)** According to the Existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

**Note:- (6)** Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, issued by Revenue Authority at the time of OTR verification of original documents.

**Note:- (7)** The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.
