Note: (2) According to the existing procedure, revaluation of Answer Script is not allowed. The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission. (i.e. on or before 01.09.2026). Applications for rechecking received after the stipulated time will not be considered and fees once remitted will not be refunded. The result of rechecking of OMR answer script will be intimated in due course..

Note: (3) Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked list uploaded in the website of the Commission (i.e. on or before 01.09.2026). A copy of an answer sheet will be issued to a candidate only once. Copies of OMR answer sheets invalidated due to any defect will not be issued. Applications submitted through email/by post/in person will not be considered. Please note that in the case of Ranked Lists of those posts for which common examinations are conducted, the copy of OMR answer sheets will be provided only after the publication of all the Ranked Lists of those posts for which the candidate has participated. Fees once remitted will not be refunded.

Note: (4) The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the The Regional Officer, Kerala Public Service Commission, Regional Office, Kozhikode, 673020 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

Note: (5) Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to THE SECRETARY , KERALA PUBLIC SERVICE COMMISSION, PATTOM, THIRUVANANTHAPURAM, 695004 either directly or post. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The

request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.

Note: (6) Since a common OMR test with common candidates was conducted for the post, the marks awarded to the candidates included in the Ranked List will be published only after the publication of entire Ranked Lists which will be finalised on the basis of the common test.
