Note 5. According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after publication of Ranked List . Detailed instructions will be published in the Ranked List to be published for the post.

Note 6. Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O(P)No. 81/2009/SCSTDD Dated 26.09.2009 issued by the Revenue authority along with other documents at the time of OTR Verification.

Note 7. The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note 8. Copy of answer scripts of the OMR Test held on 23.05.2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
