Note:- (5) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD dated. 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 along with other documents at the time of One Time Verification of original documents.

Note:- (6) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note:- (7) Copy of answer scripts of the OMR Test held on 23-05-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No. ER7-1/5/2026-KPSC dated 06/08/2026.
