Note:- (2) **21 (Twenty One)** eligible and qualified candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short list. The marks secured by the last candidate in the Main List is **52.0000 (fifty-two)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note:- (3) The Short List has been prepared based on the details furnished by the candidates in the Application and subsequent claims, if any, made will not be entertained at any stage of selection.

Note:- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Registration Verification and Interview. **Date, Time and Venue of OTR Verification and Interview will be intimated in due course through SMS/Profile Message.**

Note:- (5) According to the existing procedure revaluation of answer scripts is not allowed but, answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.

Note:- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 , SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar and candidates belonging to EWS category are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with relevant documents at the time of OTR verification of original documents.

Note:- (7) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose Application found otherwise defective will be deleted from the short list without further notice.

Note:- (8) Copy of answer scripts of the OMR Test held on 08.05.2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER2-1/4/2026-KPSC Dated 05.08.2026.
