Note:- (2) **278 (Two Hundred and Seventy Eight)** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short list. The marks secured by the last candidate in the Main List is **50.7128 ( fifty (point) seven one two eight )** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates.

Note:- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note:- (4) **Candidates included in the Short List should be present in person for Endurance Test. Date, Time and Venue of Endurance Test will be intimated through SMS and Profile Message. The shortlisted candidates should download their admission tickets for the Endurance Test from their OTR profiles logging on to the official website - [www.keralapsc.gov.in](http://www.keralapsc.gov.in) of the Kerala Public Service Commission and appear for the test with necessary documents.**

Note:- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009 , SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahsildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.3/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (7) Copy of answer scripts of the OMR Test held on **23-05-2026** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER7-1/5/2026-KPSC Dated : 06/08/2026
