No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission.
