Applications are invited from qualified Scheduled Caste/Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration.

- 1 Name of Department** : INDIAN SYSTEMS OF MEDICINE
- 2 Name of post** : **MEDICAL OFFICER (AYURVEDA)**  
**(Special Recruitment for SC/ST)**
- 3 Scale of pay** : ₹.39500-83000/-
- 4 No. of Vacancy** : **03 (Three)**

**Note** The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list is published after the expiry of the minimum period of one year. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled Castes/Scheduled Tribes during the currency of the list. Candidates shall also be advised from this list against vacancies exclusively reported for Scheduled Tribes and only in the absence of Scheduled Tribe candidates in this list, fresh notification for Scheduled Tribes will be issued for vacancies reserved exclusively for them.

**5 Method of Appointment** : **Direct Recruitment**  
(Special Recruitment from Scheduled Castes/Scheduled Tribes).

**Note** Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

**6 Age** : **19 - 46**  
Only Candidates born between 02.01.1975 and 01.01.2002 (both dates included) are eligible to apply

for this post. No other age relaxation will be allowed.

**Note :** In the absence of qualified candidates within the age limit upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

#### **7 Qualifications:**

- i) A Degree in Ayurveda awarded or recognised by any of the Universities in Kerala or equivalent qualification.
- ii) 'A' Class registration in the Travancore - Cochin Medical Council.

**Note :** 1. Rule 10(a)(ii) of part II of KS&SSR is applicable for this selection.

2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

**8 Probation:-** Every person appointed to this Category shall from the date on which he joins duty be on probation for two years on duty, within a continuous service of three years.

#### **Mode of Submitting application**

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information

and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

- 13** Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(MS) No.142/72/PD dated 13.04.1972, G.O. (MS) No. 309/73/PD dated 29.11.1973, G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Castes and Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
- 14** If written /OMR/Online Test is conducted as part of the selection, candidates shall submit a confirmation for writing the examination through their One

Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

- 15** Candidates who erroneously claim qualification, experience etc. and attend or abstain from attending examinations after providing confirmation are liable for disciplinary action as stipulated in Rules 22 of KPSC Rules of procedure 1976.
