Applications are invited online only through One Time Registration from qualified candidates belonging to the reservation group of Scheduled Caste Community for appointment in the undermentioned post.

(i)The number of candidates to be included in the Short List/Probability List of the above post will be decided as per the availability of admitted applications.

(ii)The above vacancy is existing at present. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 23.05.2016 for the post (Category No:199/14).This is the 4th NCA Notification published due to the non availability of candidates as per the Ist NCA notification in the Gazette dt: 30.12.2016 (Category No: 506/16) and 2nd nd NCA notification in the Gazette dt: 26.07.2018 (Category No:102/18)for the post and 3rd NCA notification in the Gazette dt: 31.12.2019 (Category No:560/19)for the post.

(iii)The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that,the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5	Method of appointment :	Direct Recruitment(Candidates belonging to Scheduled caste community only) Note:The applications submitted by candidates belonging to the communities other than Scheduled Caste will be summarily rejected .No rejection memo will be issued to them individually.

6	Age Limit	18-41;Only candidates born between 02.01.1980 and 01.01.2003 (both dates included) are eligible to apply for this post. (Including the relaxation as per para 2(i) of Part II of General conditions) .

Note:- The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

- 1 Rule 10 a (ii) of Part II of KS&SSR is applicable.
 - 2 Women are ineligible to be appointed to the post .
 - 3 Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
 - 4 In the case of difference in original caste/community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of certificate verification.
 - 5 Appropriate disciplinary/penal actions as per Rule 22 of KPSC Rules of procedure, will be initiated against those candidates who give confirmation for writing the examination by providing false claim about their qualifications /experience irrespective of whether they have attended or abstained from the examination

8. Mode of submitting applications :-

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User- ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. The photograph uploaded should be taken after 31.12.2011. Name of the candidate and date of photograph taken should be printed legibly at the bottom

portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a print out of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of the password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, age, community etc. have to be produced as and when called for .

(b).If a written/OMR/On-line Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The application of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard will given to the candidates in their respective profiles and in the mobile phones registered in it.

(c) Candidates who have Aadhaar Card should add Aadhaar Card as ID proof in their profile.
