- **Note**:- Details regarding standards of Vision should be clearly stated in the certificate as given above and vague statements such as Vision Normal, 'Good', 'Average', etc will not be accepted. Specification for each eye should be stated separately. If the Specification are not as indicated above, the Officer issuing the certificate should certify whether the candidates has got better standards of Vision or worse standards of Vision, as the case may be. Other wise the certificate will not be accepted.
- **Probation:-** Every person appointed to the above post shall from the date on which he/she joins duty be on probation for a total period of two years on duty within a continuous period of three years
- **Test:-** Every person appointed to the post shall pass the following tests within the period of probation.

(ii) Kerala Port Department Test (Higher Grade)

8. Mode of Submitting applications:

The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after the last date fixed for receipt of applications. The application submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. The profile correction made by candidate in the office of KPSC on request after the last date fixed for the receipt of application will not reflect in the application. Such corrections will be in effect on the date on which correction have been made.

If a Written/OMR/ Online Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar.
