- (iv) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- **5.** Method of appointment :- Direct Recruitment (Candidates belonging to Hindu Nadar, Muslim communities only)

:- <u>20-39.</u> Only candidates born between 02.01.1978 and 01.01.1997 (both dates included) are eligible to apply for this post in the case of Hindu Nadar, Muslim communities. [Including the relaxation as per para 2 (i) of General Conditions].

## 7. Qualifications:-

1. A pass in Plus Two/Pre-Degree (With Science Subjects) Course or pass in VHSE (with Science Subjects) or VHSE in Domestic Nursing of a recognized University or its equivalent.

2. A pass in Bsc Nursing of a recognized University or a pass in General Nursing and Midwifery Course having not less than 3 years duration from any institution recognized by Government.

3. Certificate of Registration with Kerala Nurses and Midwives Council as Nurse and Midwife, in the case of women candidates and as Nurse in the case of male candidates.

Note :- KS & SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.

**8.** Mode of submitting Applications :-

They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing.
