- Note:- (i) Conventional type applications will be summarily rejected. Candidates shall apply online only by One Time Registration to <u>www.keralapsc.gov.in.</u>
 - (ii) In the absence of suitable candidates, the vacancies set apart for By Transfer recruitment shall be filled up by the candidates from the Ranked List prepared for Direct recruitment.
 - (iii) The applicant should be an approved probationer/Full member of the Kerala General Education subordinate service as on the date of application.
 - (iv) A ranked lists will be prepared for Kannur district in pursuance of this notification. Ranked list thus prepared and published by the Commission shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years which ever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
 - (v) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district.
