THIRD N.C.A. NOTIFICATION

Applications are invited Online only by “ONE TIME REGISTRATION” Scheme from qualified candidates belonging to reservation group of Scheduled Tribe community in the State of Kerala against NCA vacancy for selection to the under mentioned post in Kerala Government Service.

1. **Department** : Social Justice
2. **Name of Post** : Caretaker (Female)
3. **Scale of pay** : ₹ 10480-18300/-
4. **Number of vacancy** : Scheduled Tribe-1

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for the above mentioned community but remain unfilled and also against vacancies that may arise due to the paucity of candidates during the currency of the Ranked list No. 322/14/SSIV dtd 4.06.2014 This is the Third NCA Notification issued due to the paucity of candidates belonging to the above community after the issuance of 1st NCA Notification vide Category No.733/14 published in the gazette dated 31.12.2014 and II nd NCA Notification vide category No. 176/16 published in the gazette dated 30/06/16.

5. **Method of appointment** : **Direct Recruitment** (From candidates belonging to the Scheduled Tribe community only)

NOTE: Applications submitted by the candidates belonging to communities other than Scheduled Tribe Community will be rejected. Individual rejection memo will not be issued to them.

6. **Age** : **18-41** [Only candidates born between 02.01.1976 and 01.01.1999 (both dates included) are eligible to apply for the post including the relaxation as per para 2 (i) of the General conditions.

Note : For other conditions regarding the age relaxation, please see part II of the general conditions except para 2 (i)

7. Qualifications

(1) PDC or + 2 or equivalent and One year experience as a care giver in any of the Child Care Institutions recognised by the Kerala State Orphanage Control Board under Social Welfare Department.

(2) Should possess good physique

NOTE :- (1) (i) Care Taker (Female) appointed by Direct Recruitment/Promotion shall undergo an inservice Training for a period of 3 months under the supervision and guidance of the Probation Officer of the District in which he is appointed as per the detailed programme determined by the Director of Social Welfare.

(ii) The training Period under clause (i) shall be treated as duty for all service benefits.

(2) Only female candidates are eligible for direct recruitment to the post.

In the absence of candidates with the above qualification candidates with the qualification prescribed below will be considered.

(1) Pass in Pre-degree Examination of any recognised University.

(2) Experience for a period of One year as Caretaker in any approved Juvenile Institution in Government or approved Children's Home like Orphanages etc. approved by the Control Board/Director of Social Welfare Department/ Government.

- Note :-
1. Rule 10 (a) (ii) of Part II KS&SSR is applicable.
 2. The post is exclusively reserved for female candidates
 3. The name of the institution and period of service should be furnished in the column prescribed for noting the experience in the application.
 4. The veracity of the Experience Certificate will be subjected to scrutiny and those who issue or produce bogus Certificate will be subjected to legal proceedings. The experience Certificate obtained from private institutions shall be got attested by an authorised officer of Central or State Government (The District Social Welfare Officer). Candidates should produce experience Certificate in the form appended below.

8. Mode of submitting Applications:

- (a) Candidates must register as per “ONE TIME REGISTRATION” with the Official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply now' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote User-Id for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc have to be produced as and when called for.
- (b) “If a Written/OMR/Online Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket **for 15 days from this date.** Candidates who have downloaded the Admission Ticket will alone be permitted to attend the Examination.”
- (c) Candidates who have AADHAAR Card should add AADHAAR Card as I.D. Proof in their profile.
