Note:-(i) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.

- (ii) A Ranked List will be prepared for Pathanamthitta, Alappuzha, Idukki, Palakkad, and Kozhikode Districts in pursuance of this notification. Ranked Lists thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in following district.

- (iv) The candidates belonging to above reservation communities shall submit application for this post to Pathanamthitta, Alappuzha, Idukki, Palakkad and Kozhikode districts where the vacancy is in existence for the community and shall note the name of that districts against the relevant column in the online

application.

- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

**5. Method of appointment** : Direct Recruitment (From candidates belonging to Dheevera, Viswakarma, LC/AI, OX, OBC communities only)

**6. Age Limit** : **18-39.** Only candidates born between 2.1.1978 and 1.1.1999 (both dates included) are eligible to apply for this post in the case of candidates belonging to Dheevera, Viswakarma, LC/AI, OBC & OX communities. [Including the relaxation as per para 2(i) of General Conditions].

**18-41.** Only candidates born between 02.01.1976 and 01.01.1999 (both dates included) are eligible to apply for this post. In the case of OX candidates who have converted to Christianity from SC communities after attaining the age of eighteen years and the children of such parents [Including the relaxation as per para 2(i) of General Conditions].

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification, except para 2(i).

## **7. Qualifications:-**

(a) General:

(i) A pass in Pre-Degree or equivalent examination with not less than 50% marks or B grade in Science subjects. Relaxation of 5% marks to Socially and Educationally Backward Communities who come under the purview of G.O (P) 208/66/PD dtd 21.05.1966 and subsequent orders/amendments.

(ii) SSLC or equivalent for Ex-servicemen who have passed Class I Blood Transfusion Assistant Test and have put in not less than 15 years service in the Armed Forces.

(b) Technical: A pass in one year Medical Laboratory Technician's Training Course conducted by the Medical Colleges in Kerala or by the Public Health Laboratory, Thiruvananthapuram, or any qualification equivalent thereto.

*Note: 1. In the case of persons who have completed Degree Course in Science 'B' Grade in Pre-degree examination will not be insisted.*

*2. KS&SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.*

8. **Last date of receipt of applications :31.01.2018** Wednesday upto 12 midnight.

9. **Mode of submitting Applications :-**

Candidates must register as per “ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission, viz, '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for. **Candidates who have Aadhaar Card should add Aadhaar Card as ID proof in their profile.**

Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
