apply for the post.

7 Qualifications:

1) Post Graduate Degree in any branch with not less than 50% marks awarded by any of the Universities in Kerala or an equivalent qualification

- 2) certificate (Minimum One Year duration) in Cosmetology and Beauty Parlour Management from a Government recognized Institution.
- Note :- 1. Preference will be given to persons having additional qualification of Diploma in Computer Application from a recognised Institution.
 - 2. All the Educational qualifications for teaching posts should be one acquired after a regular course of study from a recognised University in Kerala or recognised as equivalent thereto by any of the Universities in Kerala.
