Before applying for the post, candidates should register as per the One Time Registration through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile. The Photo uploaded through One Time Registration should be taken after 31.12.2010 and also bear the name of candidate and date of taking photograph in the bottom portion of the photograph. The uploaded photo will be having a validity of ten years from the date of photography. **Candidates who have AADHAR CARD should add AADHAR Card as I.D. Proof in their Profile.**

Note:- (1) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidates if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of his/ her probation or 240 days

from the date of his/ her joining duty whichever is earlier.

(4) Method of Appointment : By transfer appointment from LGS and Ministerial employees working in Kerala Water authority

Note:- 10% of the Vacancies in the cadre of Lower Division Clerk will be reserved for persons working in any of the lower categories included under this Rule or Kerala Water Authority Public Health Engineering service Rules/Kerala Water Authority Technical Special Rules holding posts within the purview of the commission (employees should be approved probationer/full member in respective feeder Categories) who secure not less than 40% marks in the eligibility test conducted by Public Service Commission. The names of low paid employees who secure 40% marks and above in the selective test conducted by the Public Service Commission and thus became qualified for appointment as Lower Division Clerk, but could not secure appointment before expiry of the ranked list will be included at the top of the new separate ranked list of Low paid employees irrespective of their service and seniority and they will be given appointment accordingly.

6. Age: Upper age Limit for direct recruitment is not applicable for this selection

Note:- Candidates applying for this post are not eligible for benefit entitled to PH candidates.

8. Mode of submitting applications:

Candidates shall register as per 'ONE TIME REGISTRATION ' on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates can view and print the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, Candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the commission. Application submitted is provisional, and can not be deleted or altered after submission. Applications will be summarily rejected, if non compliance with the notification is found in due course of processing. Documents to prove Qualification, Experience community, age etc. have to be produced as and when called for.
