- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. 1. A pass in Plus Two/Pre-Degree (With Science Subjects) Course or pass in VHSE (with Science Subjects) or VHSE in Domestic Nursing of a recognized University or its equivalent.

2. A pass in Bsc Nursing of a recognized University or a pass in General Nursing and Midwifery Course having not less than 3 years duration from any institution recognized by Government.

3. Certificate of Registration with Kerala Nurses and Midwives Council as Nurse and Midwife, in the case of woman candidates and as Nurse in the case of male candidates.

Note :- KS & SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.
