Application must be submitted online through the Official website of the Commission after One Time Registration at the Commission web site www.keralapsc.gov.in. Candidates who have already registered can apply through their profile. Candidates who have AADHAAR card should add AADHAAR as I.D. Proof in their profile.

Women candidates and differently abled candidates are not eligible to apply in response to this notification.

The first NCA notification is issued due to the paucity of candidates belonging to the LC/AI and OX communities. The selection in pursuance of this notification will be made for battalions mentioned above. Candidates appointed to a Battalion will be allowed transfer only to the District Armed Reserves concerned as shown above.

Note:

- (i) *Candidates are prohibited from applying to more than one battalion in response to the notification.*
- (ii) *Applications for the post shall be submitted in online mode only and applications submitted otherwise will be summarily rejected*
- (iii) *Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to such candidates.*
- (iv) *The above vacancy is now in existence. The Ranked List published as per this notification will be valid until a candidate is advised and appointed against the vacancies earmarked for the above mentioned community, but remain unfilled and also against vacancies that may arise due to the paucity of candidates during the currency of the Ranked List published on 17.11.2014 (KAP IV) and 01.12.2014 (MSP) (Gazette dated 29.07.2011 Category No. 267/2011)*

5. Method of appointment : Direct Recruitment only from candidates belonging to the communities mentioned above (Battalion wise)

6. Age Limit 1) **18-29**
Only candidates born between 02.01.1988 and 1.1.1999 are eligible to apply for this post (both dates included). This is inclusive of age relaxation as per General Conditions 2(i) of Part II of Gazette notification.

2) **18-31**

For candidates belonging to OX community, who have converted to Christianity from SC community after attaining 18 years and children of such parents i.e only candidates born between 2.1.1986 and 1.1.1999 are eligible to apply for this post (both dates included)

Note : Ex-Servicemen are eligible to apply upto 40 years of age. Other conditions regarding age relaxation in para (2) of general Conditions are not applicable to this selection.

7. Qualifications (a) **Educational:**

(i) Must possess S.S.L.C or its equivalent qualification.

(ii) Must possess a current heavy duty (both passenger and goods) driving license with badge. The license should remain valid on last date of receipt of applications, date of OMR test, date of practical test and date of advice

(iii) Proficiency in Driving Heavy Motor Vehicles (H Test + Road Test) (to be proved by a Practical Test Conducted by the Kerala Public Service Commission)

Note: Possession of license for driving Motor Cycle shall be a desirable qualification

(b) **Physical Qualifications:**

i) **Height** : A minimum of 160 cm

Chest : A minimum of 76 cms with a minimum expansion of 5 cm

ii) **Eye Sight** : Must be certified to possess the visual standards specified below without glasses.

Note:-

The physical measurement of candidates will be taken prior to the Practical Test (Driving) and those who do not possess the prescribed physical measurement at that time will not be admitted for the Practical test (Driving).

The candidates should produce a Medical Certificate in original in the form prescribed hereunder certifying to their physical fitness and eye sight without glasses at the time of Practical Test and upload the same in their profile at the time of certificate verification. Part A of the Medical Certificates should be obtained from a Medical Officer under the Government not below the rank of an Assistant Surgeon/Junior Consultant and Part B from an Ophthalmologist in Government Service.

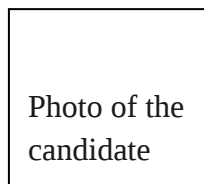

Note: Details regarding standards of vision should be clearly stated in the Certificate as given above and vague statement such as Vision 'Normal' 'average' etc will not be accepted. Specification for each eye should be stated separately. If the specification are not as indicated above, the officers issuing the Certificate should certify whether the candidate has got better standards of vision or worse standards of vision as the case may be, otherwise the Certificate will not be accepted.

8. Mode of submitting applications:

Candidates must register as per 'ONE TIME REGISTRATION' with the official

Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The Photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc have to be produced as and when called for.

9. Last date of receipt of applications :-06-12-2017 Wednesday upto 12 midnight.

10. If Written Test/OMR Test/Online Test is conducted as a part of the selection Admission Tickets for eligible candidates will be made available in their Profile created after One Time Registration and the date of downloading will be included in the Examination Calender. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
