The maximum age limit shall in no case exceed 50 years (For other conditions, please see Sub para vi, vii, of para 2 of part II of the General Conditions)

**Note:**- 1. 3% of the total vacancies reported shall be reserved for eligible differently abled candidates ( Candidates with Locomotor Disability/Cerebral palsy, Low vision, Hearing impairment vide G.O(p)No.57/11/SWD dated 22.11.2011)

(2)The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern.
