- (iv) The Candidates belonging to above reservation community shall submit application for this post only to anyone district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.

18-41. Only candidates born between 02.01.1974 and 01.01.1997 (both dates included) are eligible to apply for this post.

In the case of OX candidates, if Candidates belonging to adult members of Scheduled Caste and their children when such adult members are converted to Christianity.

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification except Para 2 (i).

7. Qualifications:-

- (i) Pass in S.S.L.C or its equivalent.
- (ii) A pass Certificate obtained after successful completion of Nurse Cum Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala or equivalent qualification recognised by the Government.
