7 Qualifications:

Three year Diploma in Refrigeration and Air-Conditioning from the Board of Technical Examination, Kerala or an equivalent qualification.

In the absence of the above, three year Diploma in Mechanical Engineering from the Board of Technical Examinations, Kerala or an equivalent qualification.

Note:- 1) All the educational qualifications should be one acquired after

- a regular course of study from a recognized University in Kerala or recognized as equivalent thereto by any one of the Universities in Kerala.
- 2) The total number of sanctioned posts shall be filled up by the methods viz (1) by promotion (2) by transfer and (3) by direct recruitment in the ration 2:1:7. If

- 3) Every person appointed to the post shall from the date on which he/she joins duty be on probation for a total period of two years on duty within a continuous period of three years.
