6	Age limit	:	18-36. Only candidates born between 02.01.1979 and 01.01.1997 (both dates included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities. (For other conditions regarding the age relaxation please see part 2 of the General Conditions)

## 7 Qualifications :

Three year Diploma in Mechanical Engineering or Agricultural Engineering from the Board of Technical Examination, Kerala or an equivalent qualification.

Note:- 1) All the educational qualifications should be one acquired after a regular course of study from a recognized University in Kerala or recognized as equivalent thereto by any one of the Universities in Kerala.

- 2) The total number of sanctioned posts shall be filled up by the methods viz (1) by promotion (2) by transfer and (3) by direct recruitment in the ratio 2:1:7. If sufficient number of qualified persons are not available under by promotion and by transfer method such vacancies shall also be filled up by direct recruitment method. [GO(P) No.81/2004/Gl. Edn. - 3) Every person appointed to the post shall from the date on which he/she joins duty be on probation for a total period of two years on duty within a continuous period of three years.

Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
