Applications are invited online only from qualified candidates for selection to the following post. Applications must be submitted online through the website of the Commission after 'One Time Registration'. Candidates who have already registered can apply through their profile.

1. Department : **Agriculture**
2. Name of post : **Electrician**
3. Scale of pay : **₹. 9,190-15,780/-**
4. Number of Vacancies : District wise
Ernakulam - 01 (One)

Notes :

- i) Conventional type applications will be summarily rejected. Candidates shall apply online only to www.keralapsc.gov.in.
 - ii) A Ranked List will be prepared for Ernakulam District in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year and a maximum period of three years. Provided that the said list will not continue to be in force if a new ranked list is published after the expiry of the minimum period of one year. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies if any reported during the currency of the list.
 - iii) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
 - iv) Candidates should submit the application for this post to Ernakulam district where the vacancy is existing and should note the name of the District against the relevant column of the online application.
 - (v) 3% vacancies for the post shall be reserved for eligible Differently abled candidates as per G O (P) No. 1/13/SJD dtd. 03.01.2013. (Hearing Impairment and Locomotor disability/Cerebral Palsy candidates only are eligible)
5. Method of appointment : Direct Recruitment

6. Age : 19-37. candidates should have been born between 2.1.1978 and 1.1.1996 (both dates included) are eligible to apply for this post. Usual age relaxation will be given to SC/ST & Other backward Communities.

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7. Qualifications :-

- (i) Pass in SSLC or equivalent qualification.
(ii) (a) National Trade Certificate in the trade of Electrician obtained after a course of two years training in the Industrial Training institutes.

OR

- (b) Certificate in the trade of Electrician obtained after 18 months course in the Industrial Training Institute with 6 months inplant training.

Note:- KS & SSR Part II Rule 10 (a) ii is applicable for this post.

8. Mode of submitting applications:-

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
