- (ii) A Ranked List will be prepared for Thiruvananthapuram District in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year and a maximum period of three years provided that the list will not continue to be inforce if a new list is published after the expiry of the minimum period of one year. Candidates will be advised for appointment against aforesaid vacancy and also against the vacancies if any reported during the currency of the list. In case no candidate is advised from the Ranked list till the expiry of the period of three years, the duration of the Ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (iii) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971.
