FIRST NCA NOTIFICATION

Applications are invited online only from qualified **Ezhava** Community candidates for selection to the following post . Application must be submitted online through the official website of the Commission after "ONE TIME REGISTRATION". Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be taken after 31.12.2010 and also bear the name of candidate and date of photo taken bottom of the photograph. The uploded photo will be having a validity of ten years from the date of photograph taken.

- (i) The above vacancy is now in existence. This is the 1st NCA Notification published due to the non availability of candidates as per the notifications in the Gazette dated 30.09.2009 (Category No.346/2009) for the post.
 - (ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

6.Age: 18-39 born between 02.01.1976 and 01.01.1997 (both dates included)

Note:- (i) The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It should also be clearly specified in the certificate that they were not working in the regular service of the concern.

7.Qualifications: Degree in Architecture obtained after a regular course of study from a recognised University.
