Applications are invited online only by One Time Registration from qualified regular employees belonging to Scheduled Caste of the Member Societies affiliated to Kerala State Handloom Weaver's Co-operative Society Limited (HANTEX) for appointment in the under mentioned post. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010 and also bear the name of candidate and the date of photo taken in the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

**Note:-** (i) The above vacancy is now in existence. This is the fourth N.C.A. Notification published due to the non availability of SC candidates in the Ranked List for the post of Lower Division Clerk that came into effect on 09.08.2011 (Category No.352/2008). The Ranked List published as per this notification will be valid until filling up the vacancy that arose due to the absence of SC candidates in the Ranked List published in the above said date. Vacancies that arise/may arise which are earmarked for SC candidates, during that period will also be filled up from this Ranked List.

(ii) In the absence of qualified Scheduled Caste candidates, Scheduled Tribe candidates will also be considered.

(iii) The selection in pursuance of this notification will be made on statewide basis.

5. Method of appointment : Direct Recruitment from qualified regular employees belonging to Scheduled Caste of the Member Societies affiliated to Kerala State Handloom Weavers Co-operative Society Limited (HANTEX).

**Note:-** Applications submitted by candidates who are not regular employees of HANTEX and belonging to communities other than Scheduled Caste will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age : 18-50 years. Candidates born between 02.01.1965 and 01.01.1997 (Both dates included) are only eligible for the post.

7. Qualifications:

1) Must be a regular employee who has a minimum regular service of 3 (three) years and continuing in service in any cadre in the Member Co-operative Societies affiliated to the Kerala State Handloom Weaver's Co-operative Society Limited (HANTEX).

2. B.A./B.Sc./B.Com. Degree from a recognized University with HDC/HDC&BM/JDC.

**OR**

B.Com. With Co-operation.

**OR**

B.Sc. Co-operation & Banking of Kerala Agricultural University.
