- (iv) Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should submit the application for this post to the concerned district office, where the vacancy is existing and should note the name of the concerned District against the relevant column of the online application.
- (v) Reservation community candidates should submit application for this post to the concerned district where the vacancy is existing for their respective community and shall note the name of that district against the relevant column in the application.
- (vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she

completes 5 years continuous service from the date of commencement of service in the former district.
