Applications are invited from qualified Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010 and also bear the name of candidate and the date of photo taken should be recorded in the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

- 1 Name of Department** : Kerala Vocational Higher Secondary Education
- 2 Name of post** : Non Vocational Teacher in General Foundation Course  
(Junior) (Special Recruitment from ST only)
- 3 Scale of pay** : ₹ 16980-31360/- (PR)
- 4 No. of Vacancy** 04 (Four)

**Note:-** The above Vacancy is now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for special recruitment for ST only during pendency of the list.

- 5 Method of Appointment** : Direct Recruitment (Special Recruitment from Scheduled Tribes only).

**Note:-** Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age** : 23-45  
Only Candidates born between 02.01.1972 and 01.01.1994 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

**Note:-** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

**7 Qualifications:**

I Post Graduate Degree in Commerce or Business Economics OR Economics with not less than 50% marks from any of the Universities in Kerala or an equivalent qualification.

II 1) B.Ed Degree in the concerned subject acquired after a regular course of study

from any of the Universities in Kerala or a qualification recognized as equivalent there to by any University in Kerala.

- 2) In the absence of persons with B.Ed Degree in the concerned subject, B.Ed Degree acquired after a regular course of study in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.
- 3) In the absence of persons with B.Ed Degree as specified in items (1) and (2) above, persons with B.Ed Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent there to by any of the Universities in Kerala.
- 4) In the absence of B.Ed Degree holders, candidates having Masters Degree with not less than 50% marks and who have passed State Eligibility Test will be considered. Preference will be given to those who have acquired Ph.D Degree or M.Phil Degree or qualified as Junior Research Fellowship/National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed Degree at their own expense within 5 years from the date of entry in service.
- 5) Persons who have acquired M.Ed in the subject concerned after a regular course of study and recognized by any of the Universities in Kerala are exempted from B.Ed qualification.

Note :- Part II Rule 10(a)ii of KS & SSR regarding qualification is applicable for this selection.

III Must have passed the State Eligibility Test for the post of Non Vocational Teacher conducted by Government of Kerala or by the agency authorized by the State Government.

Note :- All the educational qualifications for teaching post should be one acquired after a regular course of study from a recognized University in Kerala or recognized as equivalent there to by any of the Universities in Kerala.

### **Exemptions**

- 1) Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Government of Kerala are exempted from the State Eligibility Test for Non Vocational Teacher.
- 2) The persons who have passed the State Eligibility Test for the post HSST conducted by Govt. of Kerala are exempted from the State Eligibility Test for Non Vocational Teacher.
- 3) Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
- 4) Persons with Ph.D/M.Phil/M.Ed Degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the Universities in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.

- 5) Those who have submitted PhD Thesis and Mphil shall be exempted from SET upto the time of exemption granted by the UGC from time to time as in the case of candidates having the above qualifications from passing NET .

Explanation : Non Vocational Teacher (Junior) means post having work load of below 15 period per week per subject.

- 8. Probation** : Every person appointed to the post shall from the date on which he/she joins duty be on probation for a total period of two years on duty within a continuous period of three years.

**9 Mode of Submitting application:**

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. **Those who have Adhaar card should add Adhaar card as Identity proof in their Profile.**

- 13** Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.

**14** If a written Test/OMR Test is conducted as part of the selection, Admission Tickets for eligible candidates will be made available in their profile for One Time Registration and the date of downloading will be included in the Examination Calender, candidate can download Admission Tickets for 15 days from this date. Candidates who have downloaded the Admission Tickets wil alone be permitted to attend the examination.
