

## Special recruitment -District wise

Applications are invited from qualified **Scheduled Tribe** women candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010 and also bear the name of candidate and the date of photo taken should be recorded in the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

- 2 Name of post** : Female Assistant Prison Officer  
(SR for ST only)
- 3 Scale of pay** : ₹ 20,000-45,800/-
- 4 No. of Vacancy** : Unit Wise
- Thiruvananthapuram Unit - ST only – 1 (One)  
(This unit comprises the Revenue Districts of Thiruvananthapuram, Kollam, Pathanamthitta & Alappuzha)
- Kannur Unit - ST only – 1 (One)  
(This unit comprises the Revenue Districts of Palakkad, Malappuram, Wayanad, Kozhikode, Kannur & Kasaragod)

Note:- i) *The above Vacancies are now in existence. Separate Ranked Lists will be prepared for Thiruvananthapuram and Kannur units. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Tribe during the pendency of the list. In the absence of qualified candidates, re-notification will be published.*

ii) *The selection in pursuance of this notification will be made on a Unit basis subject to the Special conditions laid down in G.O (MS)No.92/80/Home dated 24.09.1980. All postings and transfers of members of the service shall be made by the IG of Prisons. Candidates already in Government service holding this post, in any one Unit are prohibited from applying again for this post, but they can apply to higher posts when notified.*

- iii) *The recruitment of Female Assistant Prison Officer in the Prisons Department being done Unitwise, a candidate who is appointed in a particular unit is bound to serve in any of the Institutions under the jurisdiction of that Unit.*
- iv) *Candidates are prohibited from applying to more than one Unit in response to the notification*
- v) *The name of the post, qualification and related conditions for selection is notified as per the provisions included in G.O(P)No.89/2014/Home dated 06.05.2014 and GO(P)No.266/2010/Home dated 09.12.2010.*
- vi) (a) *Every person appointed to the post shall from the date on which he joins duty be on probation for a total period of two years on duty within a continuous period of three years.*  
 (b) *They shall undergo in-service training as prescribed by the Head of Department.*  
 (c) *They shall pass Kerala Jail Subordinate Officers test within the period of probation unless they have already passed the test.*  
 (d) *Statewise Seniority List will be maintained on the warder establishment for the purpose of promotion to other categories.*

**5 Method of Appointment** : Direct Recruitment (Special Recruitment from among Women candidates of Scheduled Tribes only).

**Note:-** *Applications received from candidates other than women Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.*

**6 Age** : 18 – 41  
 Only Candidates born between 02.01.1976 and 01.01.1999 (both dates included) are eligible to apply for this post.

**Note:-** *In the absence of qualified candidates within the age limit, the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.*

**7 Qualifications**

1. Pass in S.S.L.C or its equivalent qualification.
2. Must have at least 150 cms of height.
3. **Physical efficiency test** –In addition to the above qualifications, a candidate should qualify in any Five (5) events out of Eight (8) events specified below of the National Physical Efficiency “One Star” Standard Test.

vii)	Shuttle race (25x4 metres)	26 seconds
viii)	Skipping (One minute)	80 times

Note:- The physical measurement of candidates will be taken at the time of physical efficiency test and those who do not possess the prescribed physical measurement will not be admitted for the physical efficiency test **If accidents or injuries happened to candidates while participating in the Physical Efficiency Test, they will not be given further chance to participate in the test.**

4. **Eye Sight:**

Must be certified to possess the following visual standards, without glasses. (Medical certificate from a Medical Officer not below the rank of an Assistant Surgeon should be produced as and when called for).

(c) Each eye must have full field of vision. Colour blindness, squint or any other morbid condition of the eyes or lids of either eye will be deemed to be a disqualification.

Note:- Details regarding standards of vision should be clearly stated in the Certificate as given above and vague statement such as vision Normal/Good will not be accepted. Specification for each eye should be stated separately. If the specifications are not as indicated above, the officer issuing the Certificate should certify whether the candidate has got better standards of vision or worse standards of vision as the case may be, otherwise the certificate will not be accepted.

5. Must be free from apparent physical defects like knock knee, flat foot, varicose veins, bow legs, deformed limbs, irregular and protruding teeth, defective speech and hearing.

**Note:-** 1) Differently abled persons and Men are not eligible to apply for the post.  
2) Part II Rule 10(a)ii of KS&SSR regarding qualification is applicable for this selection.

### **8 Mode of Submitting application:**

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be the one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. **Candidates who have AADHAAR Card should add AADHAAR Card as I.D proof in their profile".**

**12** Paragraphs two, three and twenty five (except the conditions laid down in the Rule 3 (c) of Part II of the Kerala State and Subordinate Service Rules) are not applicable to this selection.

- 13** Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
- 14** If a Written / OMR / Online Test is conducted as part of this selection, Admission Tickets for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket 15 days prior to the Examination will alone be permitted to attend the examination.
